- Transport on safari is provided in 4 wheel-drive vehicles. City and other similar transfers may be provided in minivans. The company reserves the right to employ the services of sub-contractors where necessary.

Booking Terms & Conditions:

- In order to confirm our clients' reservation, SVAI Luxe Escapes Limited requires a 30% deposit payment at the time of making your booking. Failure to do so will result in your reservation automatically being cancelled.
- The balance of payment is due 8 weeks (60 days) prior to the commencement date of your itinerary. Bookings made within 8 weeks (60 days) prior to departure are subject to full prepayment at the time of confirming the reservation.
- Please note that should you have been quoted in foreign currency and wish to settle payment by means of a credit card, your quotation will be converted to Tanzanian Shilling prior to the transaction being processed due to foreign exchange regulations by the Bank of Tanzania. The rate of exchange on the day that the transaction is processed will be used to determine the equivalent Shilling amount with any resulting foreign exchange differences or bank charges being for the client's account. The Bank of Tanzania prohibits Tanzanian companies from taking foreign credit card payments and keeping the payment in foreign currency. The payment has to be converted to Tanzanian shilling before it is credited to the recipient. Clients are welcome to settle payment by means of a bank transfer - in this instance the amount will be converted by your bankers on presentation of our invoice.
- It is the client's responsibility to inform and instruct their bankers that the net invoice amount must equal the funds clearing into the SVAI Luxe Escapes Limiteds' bank account and that ALL bank charges are to be borne by the client's account.

Standard Cancellation Policy:

- Penalty of 10% if you cancel more than 60 days before your tour
- 20% penalty if you cancel between 30 and 60 days earlier
- a penalty of 50% if you cancel with 15 to 30 days notice
- a 75% penalty if you cancel with 7 to 14 days notice,
- a penalty of 100% if you cancel with less than a week notice
- Official Govt Fees paid remain Non-refundable

COVID19 Policy:

- In the event of travel affected by a Legal Travel Ban by COVID-19, a notice of 14 days must be advised to proceed with any postponement of travel or cancellation (subject to Hotels/ Flights discretion)
- 0 - 7 Days, 100% cancellation applies unless otherwise agreed and subject to management and service providers discretion. We will refer to the service providers policies in this case and work parallel to theirs.
- Credit note will only be provided for future if the Policy of providers allows the same and this is strictly subject to service providers Terms and Conditions of the booking. In case of postponement, travel within 6 - 12 months from the date of postponement may be offered - subject to service providers discretion and policies and it will remain subject to any increase in rate depending on seasonality and room type availability when rebooked with new dates.
- SVAI Luxe Escapes reserves a right to offer an alternative service provider in the event of failure to re-book the same provider due to unavailability.
- This Policy does not apply to any changes made to the booking of International and Domestic Flights, standard or Covid re-booking policies will apply as per the airlines rules and subject to Airline discretion and will remain subject to any increase in rate depending on seasonality of travel dates.
